Khan Announces conversion of funds from US\$ to C\$.

TORONTO, ONTARIO, Canada, August 31, 2016 – Khan Resources Inc. ("**Khan**" or the "**Company**") (CSE: KRI) announces that the majority of US\$ funds received from the Government of Mongolia in settlement of an international arbitration award have now been converted to Cdn\$ at the average rate of 1.3050. The Company restates that the rate used to convert US\$ cash balances to Cdn\$ for the financial statements as at June 30, 2016 was 1.2942. This announcement is made pursuant to requests by a number of shareholders (primarily hedge funds) to provide notice of any conversion.
